Aboriginal Family Violence Prevention and Legal Service Victoria	FVPLS Victoria – Family Violence Community Legal Education Project	<p>This project will employ a community legal education worker at FVPLS Victoria for a period of two years to co-ordinate the organisation's community legal education ('CLE') program, focussing upon CLE in metropolitan Melbourne and other priority areas in Victoria not funded by the Commonwealth FVPLS program.</p> <p>The CLE worker, in conjunction with FVPLS staff and key Koori and mainstream organisations, will develop and provide culturally appropriate and up to date legal information through a range of means to Koori communities on issues of child protection, family law, family violence orders, victim's assistance, sexual assault, the role of police and being a victim/witness in a criminal prosecution.</p> <p>A strategy to ensure ongoing community awareness about legal and associated services will be developed to ensure increased access to justice. The project also aims to strengthen the knowledge of key agencies and workers, and improve mainstream agencies' ability to provide culturally appropriate responses.</p>	\$269,990.00	2 Years
Australian Institute of Family Studies	A new legal frontier? The role of social networking services and mobile phone technology in facilitating sexual violence	This project aims to assist in the reduction of sexual violence experienced by young people in Australia and support the legal system's ability to legislate, investigate and prosecute sexual violence that occurs through - or is aided by - social networking services. The project will engage qualitative research methods to expand the evidence-base on social-networking services and sexual violence, enhance understanding of the ways in which young people's attitudes and behaviours in this arena are formed, and improve understanding of the challenges involved in regulating this environment.	\$95,000.00	1 Year
Department of Justice	Crimes Act review and replacement	This project is the continuation of the Crimes Act review. It will enable a smooth transition from one legal system to another, and provide extensive support to lawyers, judges and all others in the justice system during the reforms. This approach builds on the strengths of all justice system agencies through knowledge sharing and joint activities where appropriate.	\$898,538.00	1 Year
Eastern Community Legal Centre	Ringwood Family Violence Integrated Response	This project will develop the partnership between agencies in Melbourne's East to assist people (especially victims of family violence) who are presenting at Court seeking Intervention Orders, both on their day in Court and also beyond it. Consultation will be used to develop integrated collaborative solutions and to pilot them at a range of levels.	\$214,540.00	2 Years
Environment Defenders Office (Victoria) Ltd	Public Interest Environmental Law project – community extension	The Environment Defenders Office (EDO) will build on previous activity in environmental law reform and research by continuing the employment of two law reform and policy officers. They will also engage a dedicated community law reform officer over two years to provide community education on law reform issues, develop community publications, assist communities to participate in relevant law reform processes, and work with environmental NGOs (eNGOs) to improve their community engagement, particularly in rural areas.	\$599,000.00	3 Years

Inside Access: An integrated community legal service for people with mental illness in Victorian prisons and secure hospitals - Legal Education and Training Worker	Inside Access provides a civil law service to people with mental illness in prisons through pro bono partnerships. This project will provide a legal education and training worker who will consolidate the work of Inside Access by providing community legal education to people in the mental health units in prison (Dame Phyllis Frost Centre, Melbourne Assessment Prison, Thomas Embling Hospital, Port Phillip Prison, Statewide Forensic Service), capacity building through professional legal education to pro bono firms and the legal sector, and maximising volunteer involvement in the program.	\$176,850.57	2 Years
Monash University	An examination of the impact of unpaid fines on disadvantaged groups and the criminal justice system - towards a best practice model.	This project will investigate the profile of the groups most subject to unpaid fines, how they come into contact with the criminal justice system and the outcomes of their failure to pay infringements. Young people, homeless people, people with disabilities and mental health issues, and people experiencing severe financial hardship all accrue significant unpaid fines disproportionately to other groups in the community. The procedure required for dealing with unpaid fines is lengthy and complex, and represents a significant burden to community legal centres in Victoria. This project will focus specifically on the supports available to these groups, who represent some of the most disadvantaged groups in society. The project will research how the current system in Victoria is meeting the needs of key stakeholders and where improvements could be made. It will then propose law reform in the area, with regard to national and international best practice in responding to unpaid infringements.	\$174,000.00	2 Years
Public Interest Law Clearing House (PILCH)	Extending the reach of PILCHConnect: a specialist legal service for Victorian not-for-profit community	This project will strengthen the Not For Profit (NFP) agencies that provide essential services to those people most at risk of social exclusion, by providing them with free and low cost, tailored legal information, training and advice. PILCHConnect 'helps the helpers' to be better governed, more effective and sustainable service providers. This maximises their ability to work to ensure fewer people fall through the cracks and become socially isolated.	\$184,441.00	1 Year
Senior Rights Victoria, Council On the Ageing Victoria	To protect older people from the risks of financial loss arising from the disposal of their assets in exchange for future care and accommodation	This project will provide a practice guide for the legal profession and a resource for the community outlining the risks associated when someone takes advantage of an older person who may be vulnerable due to failing or limited mental capacity, or because of his or her special relationship with the other party. The guide will discuss equitable principles of law to determine whether the transaction should be set aside, alternatives for structuring the transaction in ways that protect the client and charting the available remedies and explaining the processes for obtaining relief. The guide will research and explain the law, educate the public and their advisers on how to minimise the risks associated with such transactions, and advocate changes in the law to offset some of the present complexities and impediments.	\$165,740.00	2 Years

Western Region Health Centre	STAMP (Supporting Traditional African Mediators Project)	This project will enhance and extend work already begun with African-Australian communities living in the Western suburbs of Melbourne. The original project trained twenty-three traditional African leaders to undertake conflict resolution in family violence prevention and early intervention. The next phase of the project will continue this work in partnership with Footscray Community Legal Service, Victoria Police, Foundation House and Immigrant Women's Domestic Violence Service to further develop the training program and train additional African leaders. These people will develop skills and knowledge to build their capacity to provide resolutions that are informed by an understanding of the Australian legal and cultural context.
