

## Projects funded through the 2011 Major Grants

The Legal Services Board provided \$3.7 million in funding to 15 projects through the 2011 Major Grants. The Board set a priority theme for the Major Grants, which was the issue of the prevention of violence against women. Of the 15 projects funded, nine addressed this theme. The projects funded through the Major Grants are detailed in the following tables.

### Projects funded to address the priority theme – the prevention of violence against women

The Legal Services Board highlighted the issue of the prevention of violence against women as a priority theme for this year's Major Grants. Access Economics estimated that violence against women costs Victoria approximately \$2 billion per year and Australia \$8 billion (2004). Violence against women is reported to be the leading contributor to death, disability and illness in Victorian women aged 15 to 44 (VicHealth 2004). The legal system has a major role in this issue. The projects span education, research and integrated service delivery. All are striving to improve current policy and practice, improve evidence or explore new ways of doing things. Evaluation will form a strong part of each project and it is expected the learning will help improve legal service and practice in Victoria.

Barwon Youth	Youthlaw On Line	This project will provide young people from the Geelong region aged from 12 to 25 years old access via skype to a lawyer from Youthlaw's Melbourne office. Community legal education will also be delivered at a local level to young people, Barwon Youth staff and the broader youth and community sector.
Consumer Action Law Centre	Civil Law Support Project	An experienced lawyer from Consumer Action Law Centre will visit community legal centres (CLCs), including rural and regional CLCs, to provide training. The training (and related materials such as draft letters) will specifically cover the legal implications, and client options, when a low-income client is faced with legal action in relation to a debt. Follow up advice will be available by telephone and email to provide legal advice and support to CLC lawyers to assist them to apply the information, and use the draft letters, in actual cases.
La Trobe University	Improving the Justice in Mediation: a practical guide for mediators	As mediation is now an integral component of the civil justice legal system, this project will seek expert mediators' responses to real life scenarios, and produce a set of practical guidelines about how to ensure that mediation enhances access to justice. The resulting publication will provide advice and guidance to mediators and legal practitioners about justice issues in mediation.
Legal Services Bulletin Co-op Ltd (aka Alternative Law Journal)	Promoting Justice through Legal Education: Realising the Potential of Clinical Legal Education	This project is designed to promote the distinctive Australian approach to clinical legal education, pioneered at Monash University and then at La Trobe University through publication and distribution of an accessible book. The project team will engage with the judiciary and the practising profession, as well as law schools to foster approaches designed to sustainably integrate clinical methods into legal education.
Public Interest Law Clearing House (PILCH)	Infringements and homelessness: It's not fine!	'It's not fine!' will examine the large number of people experiencing homelessness and other forms of disadvantage who are also likely to have infringements and large debts to the State. Through casework, the worker will identify opportunities to change/improve laws and practices to reduce the number of fines issued to homeless Victorians, and problem areas where community legal education and other supports will prevent homeless Victorians from continuing to offend.
Social Security Rights	Social Security Online	Social Security Online is an innovative web based project aimed at addressing the legal needs of those in receipt of income support payments. Participants in the project will be able to log stories and experiences of the social security system, either anonymously or otherwise. Job services providers, as well as community and legal services, will be able to subscribe to the website and offer responses and advice to individual stories. The result will be integrated and multi-disciplined assistance and holistic outcomes for the projects participants.
